President Paul Lewis called the meeting to order at 6:35 PM

Approval of the August 17, 2016 minutes --- J.R.Keplinger moved to approve the minutes. George Crump seconded the motion. (Passed)

Treasurers Report-- Tim Ramsey was absent. Paul Lewis, in his absence, reported that there was \$5569.41 in the account.

Committee Reports---A committee member of each agency was selected to compile operational needs for the three county rescue squads. Members are: Derek Alt (Chair), Jay Fraley, Craig Strawderman, and Mary Fishel. Each member provided Derek with an overall plan, plus suggestions for their individual agency.

Derek Alt presented the budget report that he compiled. it covers but is not limited to: Education, County Medical Director, Service contracts, Supplies, fuel/maintenance, Licenses, Building, Uniforms, Accounting, Advertising, Legal, Insurance, Non medical supplies, Salary for full and Part time staff, and Operational fee request from Fraley's Ambulance Service.

HCEAA Board members and guest were presented with a copy of the purposed budget. Derek discussed the budget in detail. (Refer to handouts)

The guest present had many concerns and uncertainties in regard to the budget, the needs, and the means, some felt budget was too high, others felt not high enough, others unsure, guest feel no plan of structure, no SOP's, therefore not efficient. Guest discussion was to the extent that the budget was not voted on at this meeting. You need to decide the service you want, full ambulance in the area, county or as we are now, per Derek.

Old Business—Building – Garage door is ok, worked fine, could not find anything wrong with it, but will return on Friday. Air Conditioner has been fixed. Fuel tank at the building is property of Holtzman. Water has been fixed, Ed is going to repair commode that do not seal when flushed. Exterminator has been there.

There will be ACES Conferences at Winchester Pharmacy School building on October 15th, 2016; this is an all day class with your choice of topics to attend for CE hours, Also an EMS conference in Canaan Valley October 2016.

Fraleys EMT recertification is close to testing.

<u>MD Update-</u> DR. Rexrode, nothing has been decided, still a lot of questions on keeping up with 3 agencies, wants to set up a meeting with Derek, Jay, Paul, Mary. A meeting date will be scheduled.

<u>New Business-</u> The Ambulance Fee can be put back in effect, notified last Tuesday. County Commission is presently looking into reinstating the fee.

<u>Approval to pay invoices-</u> An additional invoice of \$1300.00 to T.J.M. Enterprises for installing the light bar on the chase unit. Motion made by J.R. Keplinger and seconded by George Crump to pay all invoices. Motion passed.
