Minutes of the April 10, 2013 meeting

Treasurer's report

Treasurer Tim Ramsey told the members the Hardy County Commission had given the HCEAA a check for \$10,000 to be able to open an account at the bank and to obtain necessary licenses, EIN's, etc. The Treasurer noted all checks will require two of the 4 officer's signatures. All officers have signed the signature cards.

Committee reports

The Ad Hoc/Liaison committee was asked to report on their meetings with Fraley Ambulance Service and Wardensville Rescue. It was moved by Dixie Bean and seconded by Andrew Funk to go into Executive session to discuss their reports based on the By-Laws Section 5-III matters involving the purchase, sale, or lease of property, advance construction planning or matters involving competition which, if made public, might adversely affect the financial interest of the state or any political subdivision. The motion passed and an executive session was entered into at 7:08 pm. The Executive Session ended at 7:28 pm and the HCEAA came back into open session at that time. The committee members are to proceed and work with Wardensville Rescue squad and report back at the next meeting. Alex Santana was asked to work up a price for the two best units fully stocked as ALS units. All of this must take place before 4/16/2013 when a contingency will meet with the Hardy County Commission.

Old Business

Insurance-

Greg Greenwalt has contacted BRIM(Steve Rawlings) to write and bind a General Liability policy for the HCEAA. It was moved by Ted Garrett, and seconded by Julian Hott, to purchase a General Liability policy for \$1,000,000. The motion carried. It was moved by Ted Garrett and seconded by Andrew Funk

to give Greg Greenwalt the authority to seal and bind the insurance as of 4/10/2013 12mn. The motion passed.

Legal Service- The next item of discussion was the obtainment of a tax exempt status. Craig Strawderman moved, seconded by Alex Santana, for Greg Greenwalt to go to Rosie Thomas for her help in obtaining the federal tax exempt status. The motion carried.

Licensing-No action. Let it be noted that Mr. March Tucker from the WVOEMS will be at the HCEAA meeting on April 24, 2013 at 7 p.m.
