President Paul Lewis called the meeting to order at 6:45 PM.

Approval of the July 20, 2016 Minutes—J.R.Keplinger moved to approve the minutes. Ron Crites seconded the motion. (passed)

Treasurers Report-Tim Ramsey was absent. Paul Lewis, in his absence, reported that there was approx. \$3, 2264.05 in account.

Committee Reports—Paul Lewis wants to establish a committee to work on fee schedule and permanent coverage with HCEAA. This committee will be composed of Craig Strawderman, Derek Alt, Jay Fraley, and Mary Fishel. Derek Alt will be the facilitator. They will meet and report back at the next meeting. It was noted that the last time a fee was collected there was approx. 70% compliance with approx. \$660,000 received. Discussion centered around possible fee schedules with commercial establishments. Jefferson County has charged businesses for years and Hampshire will be instituting one as well in the near future. Special Reports-none

#### Building, Equipment/vehicle, supplies update-

Building- Still an issue with air conditioning in front of building.

Garage doors have been fixed and are working properly. Door #3 is now posing some problems. Tim Garrett will be contacted to fix this. Another remote was purchased and is on back order. Toilets have issues with seal not properly seating during flushing A sign designating caution will be made and an attempt will be made to fix the situation. Paint has been purchased to re paint office and training room. An issue regarding the trash and litter as well as equipment left behind by CNA Class given by E.A. Hawse was discussed. It was noted that there are no guidelines established for use of the facilities. This will be addressed.

Unit 383 has been painted and equipment installed but it has not been licensed by WVOEMS yet. Unit 382 is still in need of repair.

Equipment-Monitors still need to have yearly maintenance done. Still no contact has been made with service dept. despite many attempts. Yearly maintenance contract will not be paid until this is addressed. Supplies- All supplies have been put on hold pending new medical director.

Licenses-The original inspection of facility by state OEMS that was scheduled for August 28 has been postponed until October. Preparation for the inspection has been put on hold until medical director issue is resolved.

Holtzman letter regarding propane-Holtzman submitted a letter offering propane at a set fee. Paul Lewis is to obtain more information.

#### Fraley's, Wardensville, Mathias-Baker and 9-1-1 center updates-

Paul Lewis did not have exact number of calls approx. number of calls for July were:-Fraley's-104, Mathias Baker-54, Wardensville-52, HCEAA-50

Mary Fishel reported that two new drivers are in training. No additional reports were presented by any agency.

There was discussion with the problem of Rockingham County refusing to come into West Virginia. At the same time they have dispatched units from WV to Va. This problem needs to be addressed but put on hold until staffing issue is resolved with HCEAA.

George Crump requested that Mathias Baker board member should be appointed since County Commission gave the green light for HCEAA board to restructure. It was decided to put forth Craig Strawderman's name for appointment. Paul Lewis will bring this request to the County Commission at their next meeting.

#### Work Schedules

There may be some overtime in the next few weeks due to scheduling issues.

#### Part and Full Time Employment

One medic application is still on hold at this time. Derek Alt requested that we hire another part time EMT. He has an application. Board gave Derek authority to interview and give recommendation to Paul Lewis for hiring. Mary Fishel requested to sit in on interview.

#### Phone Boxes at EMS/Fire Stations

Wrong address is registering with 911 phone in Baker. Issue is being resolved.

#### Training

Mary Fishel is presently conducting an EMT recertification class at Wardensville Rescue which will be testing on Aug. 22. Tammy Wratchford will be holding an EMT class at station 3 in Baker. There will be a state EMS Conference at Canaan Valley Resort on October 19-21

#### **Drug/Equipment Inventory**

No report

#### Medical Director update

Dr. Rexrode is satisfied with insurance coverage that HCEAA can provide. The main issue now is establishing her criteria for run reports and quality assurance. Derek is working with her to iron out details. She was unable to attend this meeting due to work schedule.

#### **New Business**

#### **County Commission Report**

At the last Commission meeting, the attorney for court case reviewed the possibility of imposing a fee. He gave several recommendations but said that it was legal to pursue that avenue at present. Commission asked Paul Lewis (HCEAA) to work up a proposal. Paul Lewis also requested \$120,000 to be placed in an account so amounts could be drawn when needed. This way a monthly request would not be necessary. This was approved by the commission.

#### Approval to Pay invoices

Liability insurance of \$13,031 needs to be paid. Motion made by George Crump to pay 1/2 of the bill at this time. JR Keplinger seconded the motion. (passed). Recurring bills were paid without further discussion.

There are some fire and EMS grants coming up but none at the present time. Ron Crites is pursuing money from grant to purchase a new engine for unit 379.

#### **Election of Officers**

Slate of officers presented: President-Paul Lewis, Vice President-George Crump, Treasurer-Tim Ramsey, and Secretary-Mary Fishel. Nominations were closed. Motion made by JR Keplinger and seconded by Ron Crites to accept slate of officers.(passed)

With no further discussion, a motion was made to adjourn by George Crump and seconded by Mary Fishel. (passed) Closed meeting at 8:45 PM
